## Letter from the Director: The 2009 Legislative Session and Beyond

Dear Friends,

The 2009 Legislative Session, which ended back at the beginning of June was one of the most difficult and unique sessions in State history. The economic downturn and accompanying state budget shortfalls resulted in some difficult decisions for state legislators at a time when the need for public services has been at it's greatest. Despite the budget difficulties, we did have some wins for children in the 2009 session, most notably the creation of the Legislative Committee on Child Welfare and Juvenile Justice. This committee, currently chaired by Assemblywoman Sheila Leslie, was much needed to provide a focus on these issues and create a forum for addressing the problems, and potential solutions, in a detailed and focused manner.



Another big issue during the session was children's healthcare, partially fueled by the continuing efforts at the federal level to implement a solid healthcare reform package. Recent studies continue to show that Nevada has one of the highest rates of uninsured in the country. Despite these rankings, conservative efforts during the session to restore some pre-session cuts to the Nevada Check Up Program were successful (although, hopefully, not short lived) and SB4 was passed to help streamline the application process for Medicaid and NV Check Up. However, although the Medicaid budget was increased to meet new demand, actual eligibility has so far exceeded the budget projections. Rumors of additional budget cuts and a special session are still looming, however, as of the writing of this letter, no official announcements have been made.

Looking forward to the 2011 Legislature, it is important to keep a couple things in mind. First, the landscape of the Legislature is about to make a dramatic change. Term limits will prevent many long-standing legislators from returning to Carson City in 2011. This means that we will be seeing a lot of new faces in the next session, at a time when hopefully our State budget will be making a recovery. It is important to make sure that you know who is running for office and where they stand on children's issues prior to casting your vote. Don't be afraid to ask the

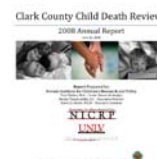

school districts to administer the Kindergarten Health Survey for the 2009-2010 school year. A few new questions have been developed for this year's survey, including questions about oral health, type of daycare/preschool that the child attended, and the child's zip code of residence, allowing for a more in-depth regional analysis. At this time, approximately 9,000 surveys have been collected and data entry is in progress. NICRP anticipates that the 2009 Kindergarten Health Survey Report will be complete by early 2010.

On October 23rd from 8:00 AM to 3:00 PM the Nevada Head Start State Collaboration Office in partnership with the Nevada Institute for Children's Research and Policy at UNLV, the Head Start State Training and Technical Assistance Office for Nevada, and the Nevada Public Health Foundation will be sponsoring the Early Childhood Summit on Comprehensive Services for Homeless Children and their Families at the Tuscany Hotel in Las Vegas, Nevada.

The Southern Nevada Maternal Child Health Coalition (SNMCH) was recently established to address issues of maternal and child health in Southern Nevada. The Coalition is a voluntary, non-profit group of individuals and public and private agencies that advocate for perinatal, maternal and child health services by promoting:

- Equal access to health care with continuous quality improvement and cost containment
- Inter-agency networking and collaboration
- Public awareness, education and prevention of adverse health outcomes
- Data collection and analysis
- Policy development, advocacy, and legislative education

The Coalition meets monthly and reports quarterly to the State Maternal and Child Health Advisory Board, providing updates and advise on related issues for the Southern Nevada area. ## *WIC Immunization Linkages Project Evaluation Complete*

The Nevada Institute for Children's Research and Policy is working with the Southern Nevada Immunization Coalition (SNIC) on a process evaluation of their WIC Linkages project. The WIC Linkages Project is a collaboration between nine local WIC office locations and SNIC to provide parents education about immunizations and no-cost immunization clinics for WIC recipient children. The SNIC WIC Linkages project is one of a number of projects implemented by SNIC in an effort to raise Nevada's immunization rate of 19 to 35 months old children to 75%. NICRP has completed the data collection for a process and outcome evaluation for the first year of the project. Preliminary results show that the project is well-received by parents and staff who are involved. For more information contact NICRP at (702)895-1040.
