### End of Summer Time Capsule

#### You will need:

- 100mm Clear Acrylic Fillable Ornaments
- Your child's favorite summertime trinkets collection
- Pen & Paper
- Permanent Marker

#### Directions:

1. Have your child gather some small items that represent their fun-filled summer like board game pieces, building blocks, seashells found at the beach, or a memorable moment caught in a picture!
2. Have your child jot down 5 things that they love about summer. Guide them with a gentle writing prompt to explain why they have included these items in their capsule to represent them. For example, "I love seeing my mom cry when I take all of her money in Monopoly." Of course, that would be YOUR child, not MY child (\*ahem\*). *Don't forget to have them include the date somewhere on this sheet so you can keep track of the years!*
3. Fill an ornament with their trinkets and the facts about their summer. Snap shut at the seams. If you are concerned about longtime storage, you can secure with a little hot glue along the seams.
4. Use permanent marker to write your child's name and the date somewhere on the ornament.
5. Find a place in your home to show off the time capsule so memories will always be remembered!

## Tips for Parents!

### August is Immunization Awareness Month

The 2017 – 2018 school year is just around the corner and beginning this school year, all Nevada students enrolling in 7th grade are required to receive one dose of the quadrivalent meningococcal conjugate vaccine (MCV4 or MenACWY), among others. Students who do



not receive their required immunizations will not be able to attend school until they are fully immunized in accordance with the State requirements. In order to ensure all students have access to all required immunizations, Immunize Nevada has partnered with Health Plan of Nevada and Truckee Meadows Healthy Communities to host a Family Health Festival offering no cost immunizations and other back-to-school services. Immunizations are available for insured and uninsured children & teens under the age of 19 on a first-come, first-

served basis, while supplies last. Those with insurance, including Nevada Checkup and Medicaid, should bring their cards. Parents should bring immunization records if available.

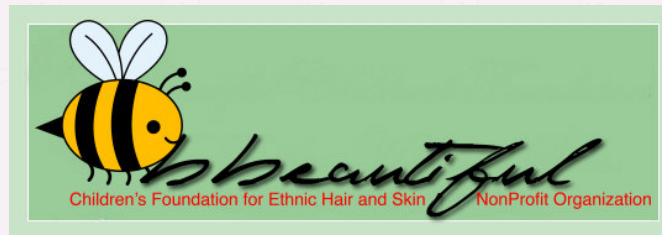
Vaccines protect against a number of serious and potentially life-threatening diseases. When children are not vaccinated, they are at increased risk for diseases and can also spread diseases to others in their classrooms and community – including babies who are too young to be fully vaccinated, and people with weakened immune systems due to cancer or other health conditions.

## Policy Updates

### Nevada Policy



### Nevada Academic Content Standards for Health Revision - Passed!

A proposed addition to the Nevada State Academic Content Standards for Health was released for review in June 2017. The purpose of the proposed revision was to provide guidance for school districts as they develop high-quality health programs throughout

Nevada schools as they pertain to Personal Safety and Safe & Respectful Environments.

The COUNCIL TO ESTABLISH ACADEMIC STANDARDS met in June to review and discuss the proposed changes to the standards. During this meeting the council voted to adopt the proposed content standards. This is great progress for our state in prioritizing the safety of our children!

### National Policy

**Key Family First Provisions  
Passed by House of**

## Representatives

The House passed five bills that highlight provisions from the Family First Prevention Services Act. Three of the bills (H.R.2742, H.R. 2857, and H.R. 2834) passed by voice vote on the suspension calendar, and two of the bills (H.R. 2847 and H.R. 2866) were passed by roll call votes. *Note: the fact that two of them had roll call votes is not meaningful. The House switches between voice vote and roll call vote for suspension bills for daily schedule reasons. A few last-minute changes, noted below, were made to three of the bills to make them cost-neutral.*



### Passed by Voice Vote

#### **H.R. 2742 – Modernizing the Interstate Placement of Children in Foster Care Act**

Introduced by Reps. Jackie Walorski (R-IN) and Danny Davis (D-IL) to modernize the interstate placement of children in foster care by requiring states to use an electronic interstate case processing system that reduces wait times for interstate foster care placements, adoptions, and guardianships. Language in this bill is aligned with section 122 of FFPSA.

#### **H.R. 2857 – Supporting Families in Substance Abuse Treatment Act**

Introduced by Reps. Kristi Noem (D-SD) and Judy Chu (D-CA) to allow family foster care maintenance payments for children placed with a parent in a licensed residential family-based treatment facility for substance abuse. Language in this bill is aligned with section 112 of FFPSA.

*New changes: When considered on its own, the Congressional Budget Office had concerns these substance abuse treatment settings would be more expensive than the foster care settings these children were already in, which led to language capping the federal payment amount for these settings to the amount the state would have received if the child was placed in a foster care setting appropriate to their needs. This bill also now requires that the child in the residential family-based treatment setting be income eligible for Title IV-E.*

#### **H.R. 2834 – Partnership Grants to Strengthen Families Affected by Parental Substance Abuse Act**

Introduced by Reps. Danny Davis (D-IL) and Kristi Noem (R-SD) and reauthorizes the regional partnership grants to strengthen families affected by parental substance abuse. Language in this bill is aligned with section 123 of FFPSA. *New changes: In the larger Family First bill, the funding for RPGs was extended into the future as part of the Promoting Safe and Stable Families (PSSF) program. Without the extension of PSSF in this standalone bill, extending the funding for RPGs would incur a cost. Therefore, the amended version of this bill for floor consideration would only amend RPG policy, not extend the funding.*

### Passed by Vote

#### **H.R. 2847 – Improving Services for Older Youth in Foster Care Act**

Introduced by Reps. John Faso (R-NY), Tom Reed (R-NY), and Karen Bass (D-CA) and extends the Chafee Foster Care Independence Program for older youth from age 21 to 23. Language in this bill is aligned with section 303 of FFPSA. Passed by a vote of 391-8.

#### **H.R. 2866 – Reducing Barriers for Relative Foster Parents.**

Introduced by Reps. Lloyd Smucker (R-PA) and Terri Sewell (D-AL) to review and improve licensing standards for placement in a relative family foster home. The intent of the bill is to address inappropriate barriers to licensing relatives as foster homes. Language in this bill is aligned with section 131 of FFPSA. *New changes: The Congressional Budget Office had concerns that administrative efforts to comply with the new state plan requirements when considered independently in this standalone bill would create an increase in federally-reimbursable costs. As a result, the amended version of the bill moves the state plan requirement on licensing from IV-E to IV-B. Passed by a vote of 382-19.*

## Senate Leaders Unveil Health Reform Proposal

In late June, a discussion draft of the new health reform bill was proposed. As opposition to the Senate health care proposal continues to build from both the right and the left, the Senate will likely spend the next three weeks leading up to the August Congressional recess working to find a compromise that can pass their caucus or determining a different path forward.
