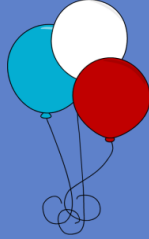

Lindsey Dickson, MD, FAPA, UFAPA, will present on "Medication Assisted Treatment of Opioid Use Disorder." She attended the University of Kentucky College of Medicine where she also completed a residency in psychiatry. She is APRN board certified in general psychiatry, addiction psychiatry and psychiatric neuromodulation. She has been on the faculty of the University of Kentucky, New York University and UNCOM and is presently Clinical Professor of Psychiatry at Texas University and Rowan University. She worked as an inpatient psychiatrist for VA Hospitals in New York City and Las Vegas. She is now the Las Vegas Medical Director for the Center for Behavioral Health which operates open the addiction program. Dr. Dickson is a Past President of the Nevada State Medical Association.

Nevada Psychiatric Association and is now the Executive Director. She has also served as a member of Clark County Medical Association and on several committees of the Nevada State Medical Association.

Supporting Teens & Young Adults with Disabilities Who Are Experiencing Relationship Abuse & Sexual Violence: Setting the Stage for Prevention

GOALS:

1. Increase awareness of the key elements of a healthy and an abusive relationship.
2. Develop a basic understanding of disabilities and how teens and young adults are targeted for abuse.
3. Ensure teens and young adult survivors of relationship violence are receiving survivor-centered, trauma-informed assistance from both domestic and sexual violence advocacy and disability service organizations.
4. Increase safety and service accessibility for teens and young adults with disabilities who are experiencing relationship abuse and sexual violence.
5. Discuss violence intervention and prevention strategies that can be used by high school/university faculty/staff, disability advocates, domestic and sexual violence advocates, and parents.

OBJECTIVES:

1. Define terminology relating to relationship and sexual violence among people with disabilities and people who are Deaf.
2. Discuss the frequency of relationship and sexual violence for people with disabilities and people who are Deaf.
3. Identify risks that would increase the likelihood of being a target of violence.
4. Identify common characteristics of an abuser.
5. Discuss the effects of sexual violence on teens and young adults with disabilities.
6. Learn ways to promote resiliency and foster protective factors for teens and young adults with disabilities and people who are Deaf and struggling to live violence-free.
7. Identify steps for achieving inclusive and accessible services for survivors; and
8. Discuss a relationship and sexual violence prevention model and incorporate strategies specific to the presentation audience.

Statement on Family Separation at the Border

In regards to the current situation at the southern U.S. border and current policy of separating children from their parents, Prevent Child Abuse America President & CEO Dan Duffy released the following statement:

“As a nation, we must set the highest standard possible in our unwavering pursuit to prevent the abuse and neglect of children. Everyone agrees that separating children from their families at our border is not a healthy or acceptable policy and counteracts our national value of protecting children. We recognize the proven science surrounding toxic stress and the lifelong negative consequences trauma can have on a child and their brain development. The data overwhelmingly demonstrates that putting a child in a confusing and frightening situation, away from their parents or caregivers, can, and will lead to long-term, negative health outcomes. It is imperative that both sides of the political aisle, the Administration and Congress, come together immediately to find a solution that strengthens families, does not separate them, and supports the well-being of all children.”

Fourth of July Craft Activities



Star Wand

Materials:

Red and blue craft felt
1 Wooden dowel
White ribbon
Scissors
Hot glue gun (or fabric tacky glue)
Glitter glue, paint, and markers

How to:

Trace a large star shape on either piece of felt. Cut out the shape, being sure to cut both pieces of felt or each individually per your preference. Glue each star to the dowel and attach a ribbon once dry. Decorate the stars using glitter, markers, or even paint!

Red, White, and Blue Pops

Ingredients/Materials:

1 cup Cranberry juice
1 cup Lemonade
1 cup Blue sports drink
8 3oz Paper or plastic cups
1 Baking sheet
8 Craft sticks

Instructions:

Arrange cups on a baking sheet and divide cranberry juice evenly among them. Place baking sheet in the freezer for 1 hour, or until juice is mostly firm. Insert a craft stick into the frozen juice, making sure it is standing upright. Divide lemonade evenly among cups to make a second layer. Freeze for around 2 hours, or until hard. Pour blue sports drink in cups to create the final layer and freeze until solid, around 3 hours. Remove completed treats from cups and serve.

Tips for Parents!

Firework Safety

- Buy ready-made fireworks rather than making your own, even from a kit
- Make sure an adult is present at all times

- Don't allow little kids to operate fireworks, even sparklers
- Buy only legal fireworks that have a label with instruction for proper use. If your fireworks don't have an instruction label it is probably illegal to use
- Always use firework outside with a bucket of water or hose
- Light fireworks one at a time. Keep the fireworks far away from your unlit fireworks
- Soak all fireworks in a bucket of water before throwing them away
- Point fireworks away from people. If you're lighting a firework, wear eye protection and don't lean over the firework

National Policy Updates

Status of Bills Addressing the Opioid Crisis

Opioid Update: Bills Target Families in Treatment and Recovery

Congress continued its work to pass bills targeting the opioid epidemic. Last week in the Senate, the Finance Committee marked up the *Helping to End Addiction and Lessen (HEAL) Substance Use Disorders Act 2018* which folded over 20 bipartisan bills into a Manager's Package. The HEAL Act makes services and supports available to eligible recipients via Medicare and Medicaid programs. Three of the bills in the package address low-income children and their families: *S. 2924 Supporting Family-Focused Residential Treatment Act*; *S. 2926 Improving Recovery and Reunifying Families Act*; and *S. 2923 Building Capacity for Family-Focused Residential Treatment Act*. The HEAL Act builds on the *Family First Prevention Services Act* (FFPSA) which passed in March and promotes keeping families together during residential treatment as well as supporting referrals, counseling, parenting and activities associated with supporting families recovering from addiction. The HEAL Act and other Senate proposals are expected to be compiled into a package to be voted on by the full Senate in the coming weeks. Read the HEAL Act

In the House, several bills focused on aspects of the opioid crisis were passed through a bipartisan agreement last week. Included in the package were:

- ***H.R. 5294*** – *Treating Barriers to Prosperity Act of 2018*, a bill to address the impact of drug abuse on economic development in Appalachia *by Rep. Barletta (R-PA)*
- ***H.R. 5752*** – *Stop Illicit Drug Importation Act of 2018* *by Rep. Blackburn (R-TN)*
- ***H.R. 6902*** – *REGROUP Act of 2018*, a bill to reauthorize the comprehensive opioid abuse grant program *by Rep. Rothfus (R-PA)*
- ***H.R. 5889*** – *Recognizing Early Childhood Trauma Related to Substance Abuse Act of 2018* *by Rep. Brat (R-VA)*
- ***H.R. 5890*** – *Assisting States' Implementation of Plans of Safe Care Act* *by Rep. Garrett (R-VA)*
- ***H.R. 5891*** – *Improving the Federal Response to Families Impacted by Substance Use Disorder Act* *by Rep. Grothman (R-WI)*
- ***H.R. 5892*** – To establish an Advisory Committee on Opioids and the Workplace *by Rep. Lewis (R-MN)*
- House Amendment to ***S. 1091*** – *Supporting Grandparents Raising Grandchildren Act* to address the impact of the opioid epidemic on families *as by Sen. Collins (R-ME)*.

The House and Senate have both stated that a comprehensive package of opioid bills will be sent to the President for signing this summer.
